As a small TK-8th grade school, Johnstonville Elementary School District believes it has a responsibility to help students and families build a solid foundation for future educational and career aspirations. Johnstonville Elementary School District is dedicated to fostering problem-solving abilities through collaboration, teamwork, creativity, imagination, and innovative thinking.

To support these goals and supplement our local priorities as outlined in our Local Control and Accountability Plan (LCAP), Johnstonville Elementary School District has strategically allocated federal funds toward three key initiatives:

- 1) Implementation of California State Standards (CSS): Federal funds are used to ensure every student receives instruction from highly qualified, credentialed teachers across a broad range of subjects. This commitment guarantees all students have access to a comprehensive and standards-based education. This aligns with our LCAP Goals #1 and #2 of providing high-quality and rigorous education and helps bridge gaps in state funding to maintain small class sizes. In addition, funds are utilized to provide instructional support by hiring an instructional aide.
- 2) Enhanced Educational Programs: Our rigorous and challenging educational programs, supported by federal funding, aim to boost proficiency in core academic areas for our TK-8th grade students. By offering a comprehensive, and well-rounded course of study, we ensure that each student is well-prepared for future educational and career opportunities. This initiative aligns directly with Johnstonville Elementary School District's LCAP Goals #1 and #2 to improve student outcomes and close achievement gaps.
- 3) Safe and Engaging Learning Environment: We are dedicated to creating a safe learning environment for all TK-8th grade students. Federal funds are directed toward fostering strong communication and participation among parents, students, and staff. By increasing teacher-parent and school-parent engagement, we aim to build a supportive and collaborative school community. This effort aligns with Johnstonville Elementary School District's LCAP Goal #3 of enhancing school climate and parent engagement, ensuring a comprehensive approach to the well-being and development of our young students.

The rationale behind these initiatives is grounded in evidence that a well-rounded education, supported by a rigorous and safe learning environment, leads to improved student outcomes. By using federal funds to supplement and enhance Johnstonville Elementary School District's LCAP Goals and state-funded priorities, we ensure that all students have the opportunity to succeed.

Alignment

Johnstonville Elementary School District will provide an effective learning environment through a rigorous and challenging educational program delivered by highly qualified teachers. In addition, while the development and implementation of a Multi-Tiered System of Support (MTSS) program did not occur with fidelity this past year, the District will refocus and prioritize this initiative in the coming years to support students struggling academically, behaviorally, and emotionally. The learning environment and student progress will be monitored through monthly Istation assessments, quarterly NWEA MAP assessments, and regular analysis of discipline data.

To foster a positive school climate, Johnstonville Elementary School District will encourage increased connections between students, their families, and the Johnstonville Elementary School District community. This approach aims to improve student mental well-being, increase school attendance, decrease chronic absenteeism, and reduce discipline issues. This will be done through regular student surveys and semi-annual family surveys.

The District will provide funding for part-time instructional assistance to support focused learning groups and implement individualized or small-group intervention plans (Action 2.3).

THIS ESSA PROVISION IS ADDRESSED BELOW:

Johnstonville Elementary School District is the smallest TK-8th grade school district in Lassen County. We strive to maintain straight grades, with one teacher per grade level, to ensure focused and dedicated grade-level instruction throughout the school day. However, during the 2023-24 school year, we had to implement two combination classes (3rd/4th and 4th/5th) due to a shortage of qualified teacher applicants. Despite this challenge, we ensure all educational opportunities are equitable and accessible to every student.

During the 2023-24 school year, Johnstonville Elementary School District had two teachers classified as ineffective according to the California State Board of Education standards, as they are currently on Short-Term Staff Permits. It is important to note these circumstances do not lead to disparities in the quality of education provided. Low-income and minority students are not disproportionately taught by ineffective, inexperienced, or out-of-field teachers compared to their peers. Our district remains dedicated to providing a high-quality education to all students, regardless of their background, ensuring equal access to experienced and effective educators.

On November 6, 2019, the SBE approved updated definitions for "ineffective" and "out-of-field" teachers to be included in the amended California ESSA Consolidated State Plan.

The District utilizes a variety of methods to communicate with parents and stakeholders throughout the year. These methods include our website, Class Dojo, monthly newsletters, weekly teacher notifications, our SIS school-to-home phone communication, our Facebook page, our Instagram, surveys, and letters sent home. Parents and guardians can access their student's attendance and grades through Johnstonville's Schoolwise parent portal. During the Back-to-School Night and Parent-Teacher conferences, parents and guardians are informed about their student's grade level state standards, state and local assessments, ways to monitor progress, and resources for support. In addition, progress reports are sent to parents/guardians, and report cards are sent home at the end of each quarter. Parents and students have the opportunity to provide Johnstonville Elementary School District with input regarding overarching goals and programs and daily operations through a variety of surveys, including the annual school climate survey (California School Parent Survey and the California Healthy Kids Survey, respectively), informal meetings, virtual roundtable discussions, School Site Council, and board meetings.

Johnstonville staff collaborates with a variety of stakeholders and the School Site Council when reviewing important information and in the development of the parent and family engagement policy. The School Site Council and the Johnstonville School Community Association (JSCA) are led by parents/guardians and provide important information regarding the effectiveness of the school's parent engagement policy and potential methods to overcome barriers to engagement. After the policy is reviewed, it is sent to the board of trustees as an information and input item on their agenda. The final parent and family engagement policy is then sent home in both the enrollment packet given to each new student and the parent/student handbook, which is given to all students.

The District held two school/community virtual round tables this year to engage a variety of families. Some of the round table topics included the LCAP, transitional kindergarten and kindergarten programs, and the after-school program. In addition, parents provided input on various school activities and operations.

Certificated staff professional development occurred throughout the school year and focused on student engagement, intentional lesson design, Universal Design for Learning (UDL), and using Depth of Knowledge (DOK) during

instructional time. Classified staff received professional development in the areas of active supervision and the importance of maintaining confidentiality.

The District utilizes the communication tools mentioned above to aid in the distribution of school-related information. In addition, we work with local agencies, the Lassen County Office of Education, and the Butte County Office of Education to bring in translators to meet reasonable accommodations, on an as-needed basis, if we have a family that needs translation services. Finally, special accommodations are made for communicating with families who have accessibility needs, or other special needs, which makes corresponding with the school difficult. For our foster youth, we strive to develop transition plans to help ease student anxiety and reduce the educational disruption that can come with frequent moves.

The District seeks parental involvement in the LCAP. Virtual roundtable and in-person meetings were held to better understand parent and guardian educational priorities and goals. The dual format approach to seek input was decided upon to help accommodate those who were not able to travel to the school site and those individuals who preferred to meet face-to-face. In addition, members of the school's classified and certificated staff provided input during meetings held in April. Stakeholder input was then used to develop a draft copy of the 2024-27 LCAP goals, metrics, and actions. This draft was shared at the regularly scheduled board meeting in May. A public hearing was held on June 18th at the regularly scheduled Johnstonville Elementary School District Board of Trustees meeting to allow members of the public to provide additional input into the LCAP. Finally, the LCAP was approved by the Board of Trustees in a separate, regularly scheduled, meeting on June 20th.

The District identifies families who qualify under the McKinney-Vento Act through enrollment and informal meetings. Once families are identified, the District provides homeless students with access to all of our programs in school without delay. Johnstonville utilizes funds to assist with needed provisions such as school supplies, and gift cards to local businesses for basic necessities such as food and clothing. The District's homeless liaison works collaboratively with outside agencies to develop a plan for giving support to the families and students at school and home. In conjunction

with outside agencies, the District also closely monitors student attendance and academic success. Based on this information, Johnstonville uses resources to develop interventions and supports, as needed. In addition, counseling services are offered to homeless students upon their enrollment and with consent from their families. This is done to reduce potential trauma that may develop due to the student qualifying under the McKinney-Vento Act.

Student Transitions

The District works closely with several local preschool programs to help transition our students into Johnstonville Elementary School District's Transitional Kindergarten and/or Kindergarten programs. Our district coordinates with local preschools regarding the needs of our English Learners, students with 504s, our McKinney-Vento students, foster youth, and/or those students who have Individual Education Plans (IEP). The District also holds a Transitional Kindergarten and Kindergarten roundup every spring to learn about our future students and the needs of the families to enable us to coordinate potential services at the beginning of school. Johnstonville School communicates the roundup activities through local support agencies, the Johnstonville School Community Association (JSCA), the school's website, Facebook, and Instagram. In addition, the Transitional Kindergarten and the Kindergarten teachers provide parents with information about Transitional Kindergarten and Kindergarten opportunities and expectations, community resources, and immunizations/health care requirements. Finally, Johnstonville School staff helps parents and guardians with enrollment paperwork at that time.

The District works collaboratively with Lassen High School District to transition 8th-grade students into the high school. Lassen High School counselors work with the students and parents throughout the second semester of the students' 8th-grade school year to discuss class and club opportunities along with assisting the families in the enrollment process. Part of the information includes the requirements for receiving a high school diploma and preparation for college and/or career options. The Lassen High School staff also holds an evening orientation event where students have the opportunity to sign up for numerous clubs available to them during their freshman year. Johnstonville School District works closely with Lassen High School regarding the needs of our English Learners, students with 504s, our McKinney-Vento students, foster youth, and those students who have Individual Education Plans (IEP).

Johnstonville Elementary School District pursues various opportunities for professional growth and improvement for teachers and school administration. These opportunities are designed to foster professional development and ensure high standards of teaching and leadership within the district.

2. School Administration and Teachers

School Administration: Johnstonville Elementary School District has only one school administrator, and as such, all professional development is customized. At the beginning of each school year, the superintendent/principal participates in dedicated professional development days alongside classroom teachers. This collaborative approach ensures that the superintendent/principal can effectively support the staff. In addition, the superintendent/principal participates in the Small School Distract Association annual conference to become well-versed in the latest educational strategies and practices.

Teachers: Johnstonville Elementary School District is committed to supporting teachers at every stage of their careers. New teachers are provided with an opportunity to participate in a teacher mentoring program. This program pairs new teachers with experienced on-site mentor teachers, fostering a supportive environment where they can discuss classroom management, pedagogy, intervention strategies, and best teaching practices. During the 2023-24 school year, three teachers participated in this program. Additionally, the District offers to cover expenses for a new teacher induction program, although there were no eligible participants in the 2023-24 school year. New, first-year teachers, also have the chance to join a new teacher community of practice established by the Lassen County Office of Education, providing them with further opportunities for collaboration and growth.

Instructional Aides: Special professional development was implemented for Johnstonville School instructional aides during the 2023-24 school. This inclusion ensures the instructional aides are equipped with the necessary skills and knowledge to effectively support classroom instruction and student learning.

3. Promotion of Professional Growth and Measurement of Improvement

Johnstonville Elementary School District's systems promote professional growth and ensure improvement through continuous professional development, mentorship programs, and collaborative practices. Growth and improvement are measured using a variety of data sources, including:

- · SBAC summative data
- Discipline reports
- Monthly and quarterly district assessments
- Attendance rates

These data points are regularly reviewed by the Johnstonville Elementary School District administration to identify areas for growth and development.

4. Support Throughout Careers and Advancement Opportunities
Johnstonville Elementary School District's professional growth systems support certificated, classified, and

administrative staff from the beginning of their careers. For new educators, Johnstonville Elementary School District offers mentoring and induction programs. The traditional school vertical career advancement is difficult due to the small size of Johnstonville Elementary School District. There is only one district/school administrator. However, teachers are encouraged to take on leadership roles within the district, such as serving as mentor teachers or leading professional learning communities. In addition, instructional aides are encouraged to pursue higher education, if they so desire. Johnstonville Elementary School District has offered release time and support for those instructional aides currently pursuing their bachelor's degree and will continue to do so as they work toward obtaining their teaching credentials.

The District evaluates its systems of professional growth and improvement through regular review and analysis of various data sources. Feedback from staff, students, and the community is also considered to make informed adjustments. Johnstonville Elementary School District administration works closely with school staff and the School Site Council to ensure that professional development activities are relevant, effective, and aligned with the District's goals.
